Test Procedure 测试程序:

1. Tests T.1 to T.5 are conducted in sequence on the same battery, Tests 6 and 8 are conducted using not otherwise tested batteries. Test T.7 may be conducted using undamaged batteries previously used in Tests T.1 to T.5 for purposes of testing on cycled batteries.

2. In order to quantify the mass loss, the following procedure is provided:

$$\text{Mass loss}(\%) = (M_1 - M_2) / M_1 \times 100$$

Where M₁ is the mass before the test and M₂ is the mass after the test. When mass loss does not exceed the values in Table below, it is considered as "no mass loss".




Fig. 2 – Back view of Power Bank
表2-电池反面视图




Fig. 3 – Front view of Cell
表3 –电芯正面视图





Fig. 4 –Sample nameplate
